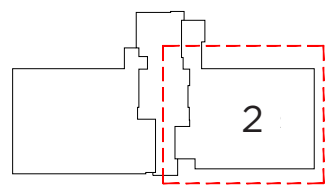
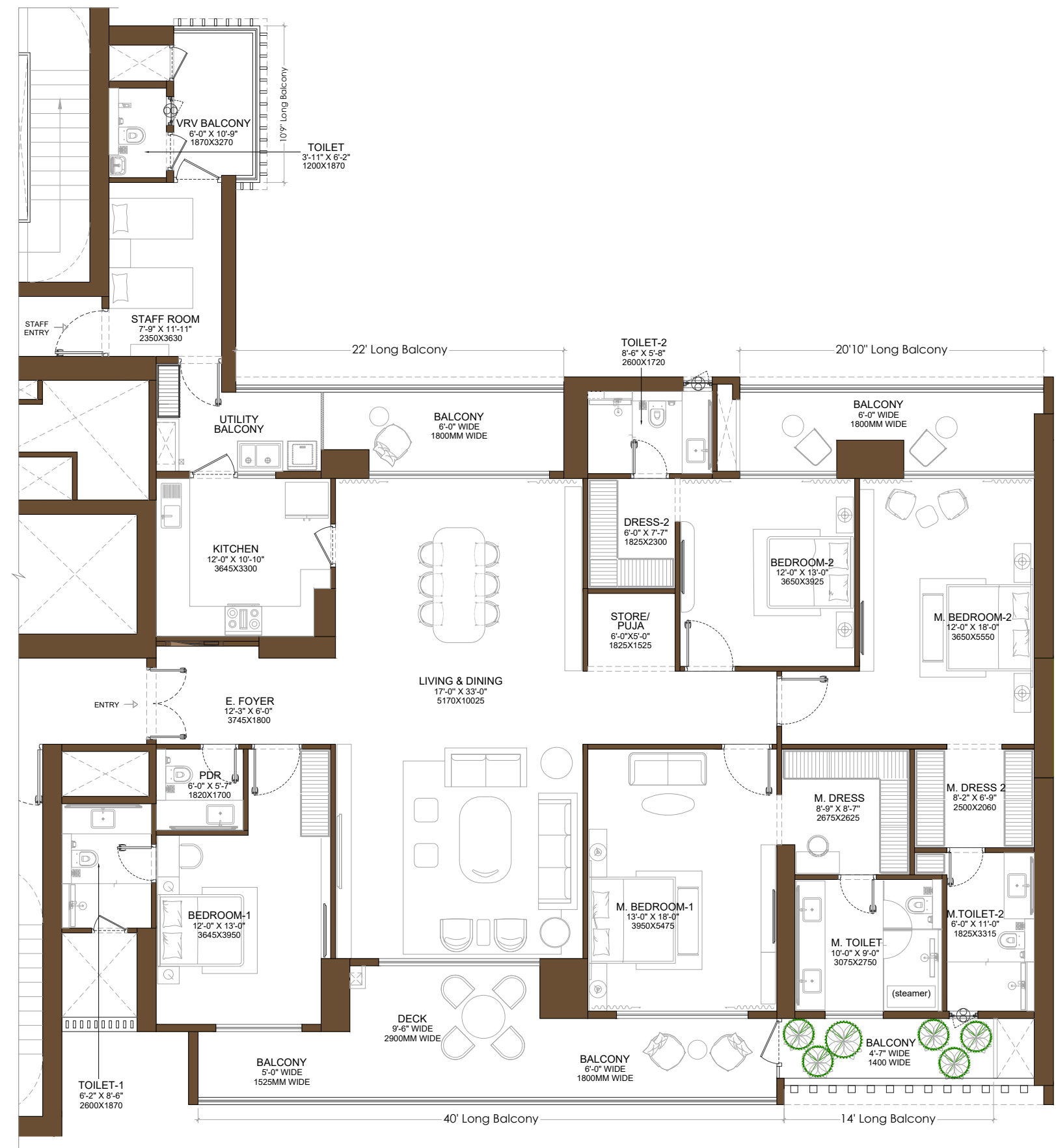


KEY PLAN

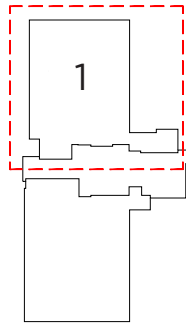


KEY PLAN

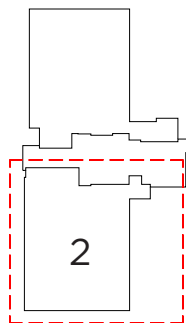
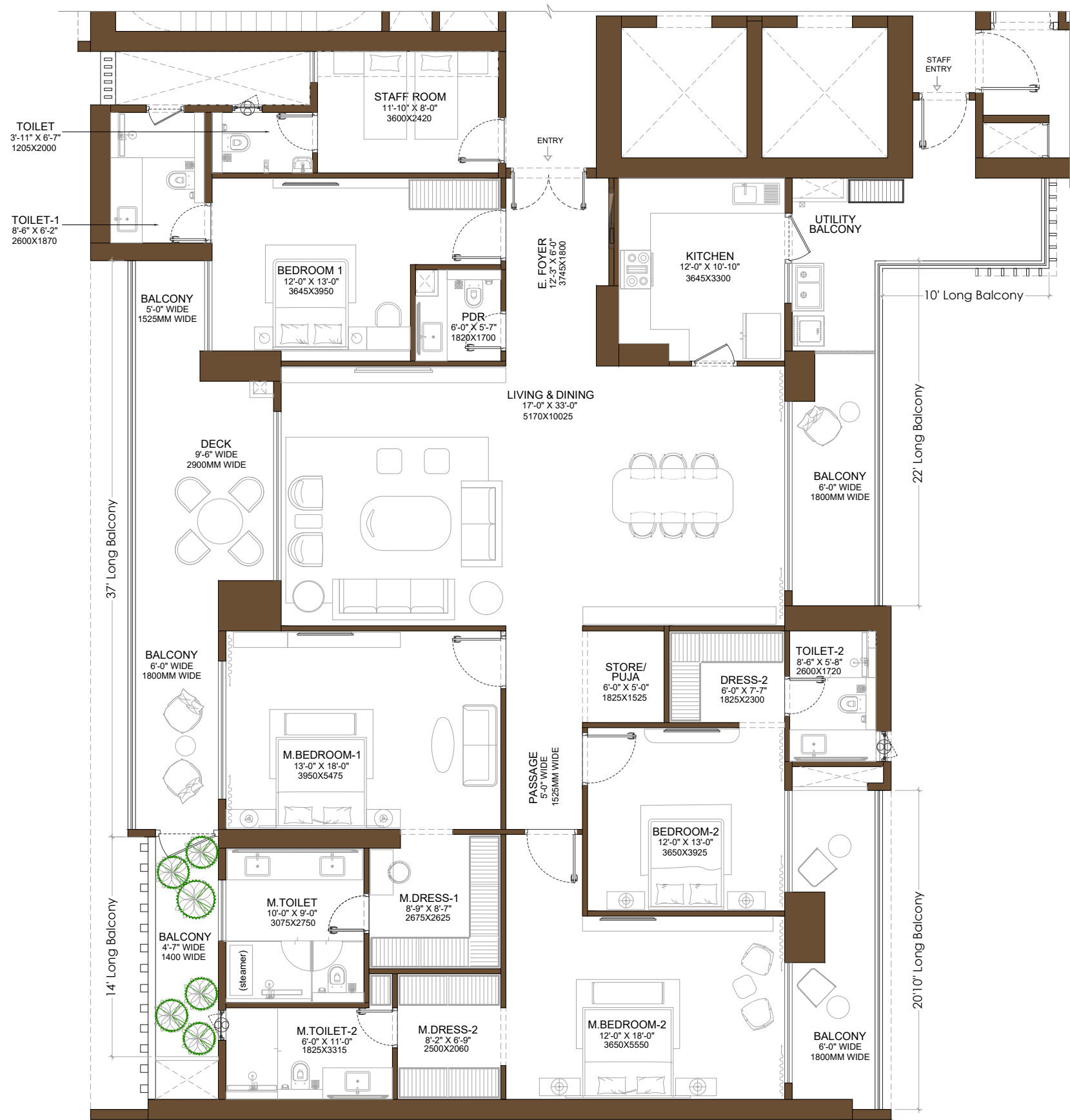
